## If we had to choose one word to describe Fiscal Year 2023, it would be renewal!

We welcomed Fr. Paul Sparklin, our first "new" pastor in over 33 years! We renovated and refurbished the pastor's residence and the historic chapel, including the vestments. Our church sanctuary was also updated with new liturgical arts, presider chairs, and a custom-made ambry. Fr. Paul has already introduced new traditions including annual blessings of our pets and nativity Bambinellis,



holding a Mass of Remembrance in November, and pastor-led bible studies for dozens of adults. We also started celebrating baptisms and first holy communions as a community at weekend Masses. We welcomed our first Seminarian intern, Pascal Atunzu! Fr. Paul led our pilgrimage to the Holy Land in March!





# **Our Parish Family is Growing**

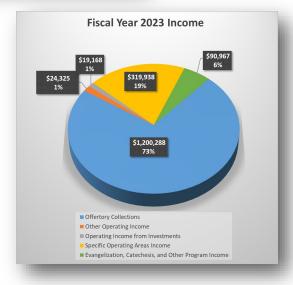
We have welcomed 21 households to our parish this year. Our Preschool opened our fourth classroom and grew to 64 children with 10 teachers. In response to the increase of young families in the parish, we started family oriented ministries including Homeschool Connect and Holy Mamas. Average weekly Mass attendance grew by nearly 19% over the prior year. We celebrated 40 baptisms, five adults who entered the church through the OCIA, 37 children who First Communions, and 50 teenagers who were confirmed in the church. Currently, 361 children are enrolled in our Faith Formation programs.



### **Our Parish Family is Generous**

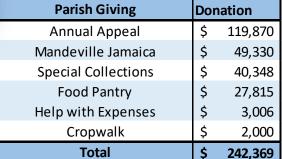
Our parish community increased offertory giving by 8%, raising approximately \$1.2 million. This sacrificial giving, along with fundraisers, fees for programs, tuition, restricted gifts, and income from endowments has enabled our parish to cover expense pressures from inflation. Our parish family is also generous beyond our walls, contributing over \$242K to other local and international ministries!

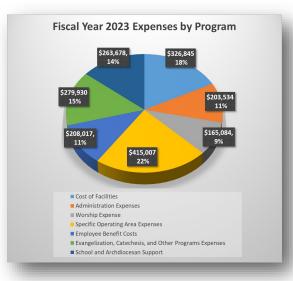




#### **Notes:**

- •73% of our operating income is received from Offertory Collections
- •19% of our Income is provided by Specific Operating Areas such as the Preschool, Bingo, Breakfast fundraisers, and rental income. Preschool operations are self funded
- •The Fiscal Year 2024 plan anticipates a 3.8% increase in offertory
